- : When handling hot material, wear heat-resistant protective gloves that are able to withstand the temperature of molten product.
- Skin and body protection : Protective clothing (e.g. Safety shoes acc. to EN ISO 20345, long-sleeved working clothing, long trousers). Rubber aprons and protective boots are additionally recommended for mixing and stirring work.
